## VA Requirements - 3Ms

### Military Service

Minimum **90 days** active duty, with at least one day during wartime, and an honorable discharge.

Gulf War veterans must have served active duty for 2 years, or the full period for which they were called for active duty.

### Medical Condition

Non service-connected disability which requires assistance with activities of daily living.

### Money Limitations

A net worth (income & assets) at or less than **\$159,000** (as of 12.1.2024)

A primary residence and auto are not counted as part of net worth. On going, unreimbursed medical and long-term care expenses may reduce income.

### For Surviving Spouses

Additional marital requirements apply.
