

VA Requirements - 3Ms

The VA's "Aid and Attendance" benefit is for wartime veterans, or their surviving spouses, who meet certain medical and financial requirements.

Military Service

Minimum 90 days active duty, with at least one day during wartime, and an honorable discharge.

World War II:
December 7, 1941 - December 31, 1946

Korean Conflict:
June 27, 1950 - January 31, 1955

Vietnam War Era:
August 5, 1964 - May 7, 1975

Served in the Republic of Vietnam: November 1, 1955 to May 7, 1975 OR Served outside the Republic of Vietnam: August 5, 1964 to May 7, 1975

Gulf War:
August 2, 1990 - until date to be determined

Gulf War veterans must have served active duty for 2 years, or the full period for which they were called for active duty.

Medical Condition

Medical condition which requires assistance with activities of daily living.

(e.g.— help with bathing, dressing, grooming, using the toilet, meal preparation, moving about safely.)

Monetary Restrictions

A net worth (income & assets) at or less than \$163,700 (as of 12.1.2025)

A primary residence and auto are not counted as part of net worth. Ongoing, unreimbursable medical and long-term care expenses may reduce income.

For Surviving Spouses

Additional marital requirements apply.
